

## 1. Activate your account.

TSA will send an activation email to the business email provided in your application.

Reminders to report are automatically generated throughout the month. Emails are generated with a [link to access the reporting platform](#).


Reminder emails will cease once data has been submitted into the platform. If you have no data to report, login and simply click on the red **'Submit'** button. This action will also stop email reminders.



## Introduction


TSA gathers data to build our understanding of the flows of tyres and tyre-derived material through the tyre industry. This data helps us to design campaigns, understand how tyres move through the value chain, and quantify the size of the activity in different locations.

We are using the following terminology when we talk about your data:



TSA would also like to understand used tyres or tyre-derived materials being sent to an off-site (temporary) storage location during the month. If material goes from Off-site Storage to a recycler or other destination, it should be reported as an Output as normal.

We are using the following process flow and terminology when we consider storage off site (transferred to a site that is not accredited):



### 3. Report used tyres & materials collected (Inputs)

In this section you will learn:

- How to set up your Inputs category filters for used tyres & materials collected.
- Understanding 'Unit of Measure' for recyclers (Tonnes).
- How to select the locations/customers that used tyres or materials are collected from.
- Entering your data.


#### 3.1 Set up your Inputs filter categories

**Filters** can be set up according to their direction – **Inputs** or **Outputs**. Use the tables provided in this guide to see tyre categories and processed material types available for selection and their codes displayed within the filter window ([Appendix A](#): Whole Tyre and Modified/Processed Material categories, codes, and using default categories).


**IMPORTANT NOTE:** The selections made at this time will be saved for the next time you login. They can be changed and re-saved at any time.

#### Select your tyre categories and types:

- Click on the **FILTERS** button to select the tyre **categories** &/or material **types** that your business receives.




- A dropdown menu will appear with tyre & material categories and their codes:

Some categories have expanded to accommodate the variety of material types and tyre sizes with varying weights at end-of-life. Default types such as CAR and SUV can be used if you are unable to split tyre sizes. Refer to bullet instructions for guidance when using default codes.

- Click on the **ALL** tick button  at the top of each category to deselect all tyre types (If all tyre or material types are relevant to your business, then leave ALL selected)
- To individually select the tyre or material types applicable to your business, click on the tick button  next to the code.  
**Note:** You can hover your cursor over the code to reveal its full description.
- Use **DEFAULT** tyre types where available if you are uncertain.



### Example of using a \*Default code (Tyre types only):

- If you are unable to split SUV, 4x4 and RV tyres by less than (<) 18inch (code SUV) and greater than or equal to (≥) 18 inches (code SUVL), place all SUV, 4x4 and RV tyres into the SUV default category code.
- Do not use "SUV \*Default" to capture other types of tyres (such as Car or Motorbike) in the Motorbike and Passenger Car tyre category.
- This logic will apply to all tyre types that contain a default under specific categories.

- Continue to select the tyre types or tyre-derived material handled by your business under each category.
  - You can remove a category if it is not relevant to your store by deselecting **ALL**.

To save your selections, click on the **CLOSE** button or use the X in the top right-hand corner of the filter window if available.

Filter settings can be individualised for each data tab.



The filter set up for Outputs and Stock Level is covered later in this guide.

### **IMPORTANT NOTE:** Applying filters for collecting tyres in pieces or shred.

If you are collecting tyres modified from their original form, such as sectioned agriculture or mining tyres, you can report either in the appropriate default category of whole tyre e.g., agriculture or mining, or by selecting the appropriate type under the Modified/Processed Material category ([Appendix A](#)) filters. Either way, please report in tonnes. See 'Unit of Measure' below.

## 3.2 Unit of Measure (Inputs)

Unit of Measure (UOM) is preset to **TONNES** for recyclers, a dark green button indicates this selection. If you prefer to report whole tyres in units, then toggle by clicking on **UNITS**.



- Note that you will need to select **UNITS** each time you login.
- Processed materials should always be reported in tonnes.

## 3.3 Select your Inputs customer/location and enter data

**IMPORTANT NOTE:** TSA requires the reporting of all locations that used tyres or tyre derived materials are collected from (where practical). TSA has made provisions for reporting against locations that are not traditional tyre retailers. If you are unable to provide a detailed report of each location collected from, please contact TSA and we will discuss with you a solution that best fits your business reporting capability.

## There are several ways you can enter Inputs:

- I. Add customer/location using the **Source Business Name or Suburb/ABN or Generic** search field for each retailer, collector, recycler, or other source (i.e. council depot etc.) and enter data directly to their business account.
- II. If you can't find your collection point in our search, then use generic **"Non-listed tyre retailer(s)"** or **"Non-listed tyre collector(s)"** source code. When using these codes combine tyre totals by type and by state (generic codes can only be used once per reporting period).
- III. If you are entering detailed data, using the bulk upload template will make this easier. (See [Appendix C](#) for guidance). If you need help, reach out to TSA.
- IV. If you are not able to split your data by individual sources, enter combined customer Inputs by tyre type as one line of data, using the generic entity "Non-listed tyre retailer(s)" (formerly known as AdminRetailer in the old platform). Use the entity that is specific to the state where tyres were collected.

## I. Add each customer/location individually

### Adding collections from retailers

To find and select your tyre retailer, start typing their business name in the **Source Business Name or Suburb/ABN or Generic** search field. Names of tyre retailers will appear as you type. Scroll down the list to find the business name.

**Helpful Hint:** Too many results? You can minimise the search results by entering the retailer's suburb instead of their business name.

- When you have found your retailer, click in the tyre type field, and enter the number of tonnes collected. **Note:** Accredited retailers will appear in **green** font, non-accredited will appear in **dark grey** font.
- If you are not able to find them in the list, you can use generic category non-listed tyre retailers(s)
- Use the Tab key (or your mouse) to move between data fields.
- If you prefer to report in **Units**, remember to change the Unit of Measure prior to entering data.

Make sure you report in tonnes and not kilograms (e.g., 1020 kgs = 1.020 tonne).

You can enter up to three decimal places.

- If you are using a small screen or laptop and cannot clearly see all the categories selected, click on the **scroll icon** (located at the top right of the category menu) to move across the page. 
- If you collect tyres from multiple retailers, finalise data in the first row before proceeding.
- To enter a new row of data, go back to the customer search and click on the **X** to start a new search.

Source-Business Name/ABN or Generic  

- Repeat this process until all retailer collections have been entered.

### Adding collections from other accredited participants in the Scheme (e.g., collectors/recyclers).

If you are receiving tyres from other accredited (non-retail) participants, search for their business name and enter data as a separate line item. Non-accredited collectors or recyclers in the list will appear in **dark grey** font.

If you are not able to find them in the list, you can use generic categories such as **non-listed tyre collector(s)** or **non-listed tyre recycler(s)** specific to their state of operation.

If you are receiving processed tyre materials, make sure you have selected filters from one of the following categories to accurately enter your data. Refer to [Appendix A](#) for a full list.

### Adding collections from other sources

TSA has developed generic categories (entities) to record collections from other sources.

The term 'Generic' is used to group Input destinations that represent industry, activities, or participant types where business names are not available in the platform. These are:

- **Non-listed mining or agriculture enterprise.**
- **Non-listed council depots or waste disposal facilities.**
- **Non-Listed Transport, Logistics or Fleet Company.**
- **Dumped tyres.**
- **Stockpile clean-up.**
- **Non-listed auto wreckers**
- **Non-listed manufacturer**

Refer to [Appendix B](#) for list of generic options including descriptions.

## II. If you have retailers or collection sites that aren't listed

To enter data relating to tyre retailers or collectors that are not listed in the platform, use **non-listed tyre retailer(s)** or **non-listed tyre collector(s)**. You will find versions of these Generic entities specific to your state of operation or state(s) you are collecting from. These codes can only be listed once, so you will need to consolidate the total tyre volumes into one line of data if you have more than one non-listed retailer or collector.

## III. Report using a Bulk Upload Template

Alternatively, you can use an Excel Bulk Upload Template to load your Inputs; refer to [Appendix C](#) in this guide to find out how to do this.

## IV. If you are unable to split your data by individual sources

In this case, enter all of your customers' Inputs totaled by tyre type as one line of data, using the generic entity "Non-listed tyre retailer(s)" (*formerly known as AdminRetailer in the old platform*).

This Generic entity has different versions specific to your state of operation or state(s) you are collecting from, collections from multiple states should be split by state.

Once you have entered your Inputs data, move to the Outputs tab.

## 4. Report modified/processed materials distributed to end destinations (Outputs).

**NOTE: TSA regards "Outputs" as anything that leaves your site.** If you modify tyres on-site but they do not leave the site, this change can be recorded in the "Stock Level" reporting tab. If you are transferring stock between accredited sites, report this as an output according to the material type when it is transferred. Refer to [Appendix A](#) – Whole Tyre and Modified/Processed material categories for a complete list of material types. If you pass on whole tyres as seconds, remember to include them in your output.

### 4.1 Select your material types and/or other types:

- Click on the **Outputs** tab.
- Click on the **Filters** button.
- Commence setting up filters following the same process as for Inputs, then click on the **CLOSE** button to save your Outputs filters.



When you are outputting tyres that have been modified, such as casings or sidewalls, or processed, such as shred or crumb, use the appropriate filter type under the **"Modified/Processed tyre categories material types"**.

The most common processed types are:

- **Shred (SHD)**
- **Steel (STL)**
- **Crumb (CRB)**
- **Granules (GRS)**

The most common modified types are:


- **Casings (CASG)**
- **Carcass (CRCS)**
- **Sidewalls (SDWS)**

## 4.2 Unit of Measure

Data for modified or processed material should always be reported in **TONNES**.




## 4.3 Select your end-market destination or TSA accredited recycler

Using the same process as for Inputs, find your **Outputs** destination by typing the business name (recycler) or generic category for end destination in '**Source Business Name/Suburb or ABN or Generic**'. The generic categories for end destination reflects the vendor applications or other end points for your product, either domestic or export. There is a mixture of direct applications, as well as manufacturers listed. For available options, refer to the miscellaneous list in [Appendix B](#).

Some common examples include:

- **Agriculture Application** – e.g., sidewalls for silage
  - **Landfill (monofil) or Landfill (disposal to cell)** – e.g. for fibre
  - **Seconds dealer (Australia)**
  - **Export – for reuse/seconds**
  - **Non-listed retreader (Australia)**
  - **Export – for retreading**
  - **Roadworks Application** – e.g. for crumb rubber modified bitumen
  - **Adhesive or sealant product manufacturer**
  - **Moulded and extruded product manufacturer** (e.g. for rubber mats)
  - **Export - substitute fuel** (for TDF or other energy uses)
  - **Steel recycler / scrap dealer** (for recovered steel)
- Where available, choose the version of the entity relevant to the state or territory where the activity occurs.
  - Output data reported as going to these destinations should be entered in the text box next to the whole and modified/processed material type that best describes the Output material. Hover your mouse over the code to reveal its description.
  - To enter output data relating to tyre recyclers not accredited in the Scheme, use generic category **Non-listed tyre recycler(s)** specific to the state you are delivering to.

- 1 Shred (SHD) being exported offshore to be used as a substitute fuel.
- 2 Crumb (CRB) being sent for use in Roadworks Applications in NSW
- 3 Shred (SHD) being transferred to another accredited recycler (Totally Recycled Tyres) for further processing

If you are unable to find a generic category that matches the end destination or are unsure about the end-use, you can use **“Domestic unknown use (state specific)”** or **“Export unknown use”**. Contact TSA if you need assistance.

Continue to process your Outputs data until completed, then proceed to the **Stock Level** tab.

## 5. Report On-site or Off-site Stock Level data

Reporting stock levels of material stored both on-site and off-site is an important aspect of being transparent as an accredited Scheme participant. This may include any tyres that are modified (e.g. shredded, crumbed or cut) that do not leave the site.

### 5.1 Reporting on-site stock levels (on-site storage)

Surplus stock that remains stored on your site at the end of the month is to be reported in the **Stock Level** tab by whole tyre type, modified tyres and/or processed tyres.

- Unit of measure is pre-set to tonnes for all stock level categories.



### 5.2 Reporting off-site stock levels (off-site storage)

Used whole tyres or modified/processed materials that are sent to an off-site (temporary) storage location during the month must be reported as an output. If any stock returns to the accredited site, it should be reported as an input. This process is shown in the diagram below (green) using the following generic categories:

- **Material going to Off-site Storage**
- **Material returning from Off-site Storage**

If material goes from Off-site Storage to a recycler or other destination, it should be reported as an Output as normal.



## 6. Updating and editing data

You can update your current period data at any time between the 1st and 28th of the reporting month by clicking on the **EDIT DATA** button.





Using a template to load your data helps TSA verify that accredited retailers are using your services. It also provides visibility for TSA to onboard retailers who are not accredited in the Scheme.


Sharing at this level of detail through data provides TSA with access to non-accredited retailers who are already compliant through use of your services, thereby extending our reach to onboard more retailers.



 This template will download with over 3000 entities (both accredited & non-accredited entities), so there is a little work in the initial set up. Once this is done you can use the same template for future reporting periods, noting the period in the template will need to be changed to the new month each time it is used.

- Click on **CTRL F** simultaneously to search and find your collection or receipt point (**Company** column).
- Highlight cells with business name using same colour (yellow in example ).
- Continue this process until you have captured all of your customers.
- If there are company's you cannot find in this list, you can consolidate missing retailer totals (by type) and enter the data against the generic '**Non-listed tyre retailer(s)**' specific to your state as a single line of data, formerly known as AdminRetailer in the previous platform version. For 'collectors' not in the list use 'Non-listed tyre collectors(s)' Refer to [Appendix B](#) for other generic options..
